



LEGAL & TAX OFFICIAL COMPETITION RULES

The competition is administered by Legal & Tax ("competition administrator").

By entering, you are deemed to have read, accepted and agreed to be bound by these official competition rules.

This competition is in no way sponsored, endorsed or administered by, or associated with Facebook inc. ("Facebook").

By entering this competition, you understand that you are providing your information to the Sponsor and not to Facebook.

ELIGIBILITY:

To be eligible, you must (a) be a legal resident of South Africa and (b) have reached the age of eighteen (18) years.

The Sponsor is not responsible for computer system, phone line, hardware, software, cable, satellite, Internet Service Provider (ISP) or program malfunctions, or other errors, failures or delays in

computer transmissions or network connections. The Sponsor is not responsible for any errors whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to, or in connection with, the competition including, without limitation, errors or difficulties which may occur in connection with the administration of the competition, the processing or judging of entries, views, postings and/or shares (as applicable), the announcement of the prizes, or in any competition-related materials. The Sponsor reserves the right at its sole discretion, to disqualify any individual and void his or her entry/ies who tampers with the entry process.

9. RIGHT TO CANCEL, TERMINATE, MODIFY OR SUSPEND:

If for any reason, any aspect of this competition is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any other cause beyond the control of the sponsor, subject to applicable laws, the sponsor may in its sole discretion cancel, terminate, modify or suspend the competition, or invalidate any affected entries. In the event that the competition is cancelled or terminated, the sponsor reserves the right to conduct a random draw from among all eligible entries received up to the time of such action. You irrevocably waive any objection on the grounds of venue, forum non-convenience or any similar grounds and irrevocably consent to service of process by mail or in any other manner permitted by applicable law and consent to the jurisdiction of the courts of South Africa. You further hereby waive any right to a trial by jury with respect to any lawsuit or judicial proceeding arising or relating to these official competition rules.

Any provision in these official competition rules which is held to be invalid or unenforceable for any reason by any court, governmental department, body or tribunal, or in any applicable jurisdiction shall be ineffective to the extent of such invalidity or unenforceability and will not invalidate or render unenforceable the remaining provisions hereof and should any provision be held invalid or unenforceable in an applicable jurisdiction such provision shall not be invalidated or rendered unenforceable in any other jurisdiction.
